GILLES AMADO

is Professor of Organizational Psychosociology at HEC School of Management (Paris). He is a founding member of the International Society for the Psychoanalytic Study of Organizations (ISPSO), of the Centre International pour la Recherche, la Formation et l'Intervention Psychosociologiques (CIRFIP), a member of the French Society for Group Psychoanalytic Psychotherapy (SFPPG). He is the author of numerous articles and books in the areas of organizational change, group dynamics and leadership.

MARINA WARNER

is a prize-winning writer of fiction, criticism and history; her works include novels and short stories as well as studies of female myths and symbols. She is currently working on a new genre of literature called Memory Maps which moves between fiction, history, traveller's tales, reverie and memoir. It explores the spirit of place and is sometimes called 'psychogeography'. Her last book, Phantasmagoria, is a study of spirits and mass media. She is Professor in the Department of Literature, Film and Theatre Studies, University of Essex.
