RENATE GROENVOLD BUGGE is an approved specialist in clinical psychology and occupational and organisational psychology. In her professional career she has had both an individual and an organizational perspective as clinician and executive director of different organizations and as consultant to organizations. Her theoretical background and base has always been the psychoanalytic and psychodynamic understanding of processes combined with the necessity of structure and clarifying of roles and tasks. She has worked as delegate for Norwegian Red Cross, and Norwegian peoples Aid in Zimbabwe, Mozambique and on Balkan, Sarajevo. After July 22nd 2011, the terror attacks in Norway, she was deeply involved as consultant both to the management in the Labour Party and to the health department in Norway. She has published and presented conference papers frequently She has been Programme Director on the board of ISPSO, and is an Opus Associate

PROFESSOR MARK SOLMS is best known for his discovery of the brain mechanisms of dreaming, and his pioneering use of psychoanalytic methods and theories in contemporary neuroscience. He now holds the Chair in Neuropsychology at the University of Cape Town and Groote Schuur Hospital. He has published more than 250 chapters and articles in both neuroscientific and psychoanalytic journals. He has published five books, including The Neuropsychology of Dreams (1997), Clinical Studies in Neuropsychoanalysis (2000) and The Brain and the Inner World (2002). His last book was a bestseller and translated into eight languages. He is the editor of the Revised Standard Edition of the Complete Psychological Works of Sigmund Freud (24 vols) and the forthcoming Complete Neuroscientific Works of Sigmund Freud (4 vols).
